

Dear TEPC Members,

On behalf of Returning officer, the following election notice is being issued by the TEPC secretariat.

TEPC had conducted its elections for the Governing Council on 16th January 2017 through e-voting for next 2 years. Election of Vice Chairman of Governing Council amongst elected GC members (subject to their export turnover) is due. Chairman, TEPC has decided to conduct election of new Vice Chairman on 21st March 2017, 9:00 hrs -15:00 hrs through e voting. But due to non receipt of nomination on time we are rescheduling the election of Vice Chairman and holding it on **16th June 2017, 09:00 hrs- 15:00 hrs.**

2. I have been nominated as Returning Officer for the conduct of above said TEPC elections.

3. TEPC Bye Laws has following provisions related to election:

4.2. b) "Where a person is standing for election as Chairman or Vice Chairman or Regional Chairman etc, he, or the entity represented by him, must have, to his or its credit, during the one financial year immediately preceding, exports of the product, of not less than Rs. 2 crores."

Further he is also required to be a member of the Governing Council. Members are advised to refer Bye Laws of TEPC and related provisions for elections.

4. Based on the result of the Governing Council election already conducted on 16th January 2017, nominees from the following four companies who are meeting the export criteria and are part of Governing Council, are eligible to file their nomination for Vice Chairman's Position as per the eligibility criteria as mentioned above:

- Intex Technologies (I) Ltd.
- Paramount Communications Limited
- Vihaan Networks Ltd
- Paramount Wires & Cables Limited

5. **Members eligible to vote**

TEPC has decided cutoff date for eligible members to vote as those who have paid their membership fee for the current year till 31st March 2017.

4. Applicable forms and other information, including the complete election schedule, are enclosed in the Annex A to Annex D to this Election Notice. Nomination is invited for the position of Vice Chairman of TEPC. Please send your scanned copy of nomination(s) addressed to the **undersigned** by email at jsa-dot@nic.in and with copy to TEPC secretariat at tepc@telecomepc.in on or before 13th June 2017 up to 12:00 hrs with hard copy by post to TEPC Secretariat.

6. Request for **withdrawal of the nominations should** be sent to the undersigned on or before 14th June 2017 up to 12:00 hrs.

7. Objections to nominations, if any, can also be mailed to the Returning Officer by 15th June 2017 up to 12:00 hrs. Final list of eligible candidates will be intimated on 15th June 2017 by 15:00 hrs through email to all eligible members' representative.

8. The process of election will be completed with the help from the TEPC Secretariat.
